

RESOLUTION
OF THE GOVERNMENT OF THE CZECH REPUBLIC
of March 13, 2020 No. 207

**on the ensuring of the provision of care in social services facilities for the period of
the state of emergency**

Following the resolution of the Government No. 194 dated March 12, 2020, according to which the Government declared, pursuant to Articles 5 and 6 of the constitutional act No. 110/1998 Coll., on security of the Czech Republic, the state of emergency for the territory of the Czech Republic due to the risks for public health in connection with the evidenced occurrence of the coronavirus /referred to as SARS CoV-2/ in the territory of the Czech Republic, and ruled to adopt emergency measures pursuant to Section 5(a-e) and Section 6 of the act No. 240/2000 Coll., on emergency management and amending of several acts (the emergency act), as amended, to solve the emergency situation, hereby, pursuant to Section 5(e) and Section 6(1)(b) of the emergency act,

The Government

I. Authorizes

1. To impose work duty to students of higher professional schools and universities with specializations as per Section 110(4)(a-b) of the act No. 108/2006 Coll., on social services, as amended, and students of secondary schools with specialization as per annex No. 4 of the decree No. 505/2006 Coll., implementing several provisions of the act on social services, as amended, to ensure due provision of care in social services facilities during the period of the state of emergency in connection with the occurrence of the COVID_19 epidemy in the territory of the Czech Republic;
2. The minister of work and social affairs to inform the regions and the capital of Prague and provide them with methodical guidance to provide care as per point I/1;
3. The minister of education, youth and physical education to provide any and all assistance to the Ministry of Work and Social Affairs, the regions and the capital of Prague;
4. The heads of regional administration and the mayor of the capital of Prague to ensure and coordinate work duty for the social services providers in their respective territories and inform the Ministry of Work and Social Affairs of measures adopted in this respect.

I. Orders

1. All social services providers, which have been granted registration for provision of the social service pursuant to Section 46 of the act No. 108/2006 Coll., on social services (day-care centers), to suspend operation of such facilities for the duration of the state of emergency, starting as of March 16, 2020;
2. The heads of regional administration and the mayor of the capital of Prague

- a) To ensure other appropriate social services or other types of care, to the necessary extent and only in cases of immediate threat to life and health of the users of the social service as per point II/1, in collaboration with municipalities in which such users have their actual place of residence.
- b) Inform the Ministry of Work and Social Affairs of the execution of the measure as per point II/2a.

mayors of the relevant municipalities
