## RESOLUTION OF THE GOVERNMENT OF THE CZECH REPUBLIC

of March 13, 2020 No. 209

## on the adoption of an emergency measure

Following the resolution of the Government No. 194 dated March 12, 2020, according to which the Government declared, pursuant to Articles 5 and 6 of the constitutional act No. 110/1998 Coll., on security of the Czech Republic, the state of emergency for the territory of the Czech Republic due to the risks for public health in connection with the evidenced occurrence of the coronavirus /referred to as SARS CoV-2/ in the territory of the Czech Republic, and ruled to adopt emergency measures pursuant to Section 5(a-e) and Section 6 of the act No. 240/2000 Coll., on emergency management and amending of several acts (the emergency act), as amended, to solve the emergency situation, hereby, pursuant to Section 5(c) and Section 6(1)(b) of the emergency act,

## The Government

Orders, with effect as of March 13, 2020, 12:00 hours

- 1. The citizens of the Czech Republic and foreigners with permanent or temporary residence permit for more than 90 days in the territory of the Czech Republic or if they are employed in the territory of the Czech Republic, who return, after the moment of effect of this resolution, from the risk areas, as specified by the minister of healthcare pursuant to the resolution of the Government of March 12, 2020 No. 198, to the Czech Republic, to inform of this their registered healthcare services provider for general medicine or, if they do not have any, any healthcare services provider for general medicine or pediatric medicine by phone or other means of remote communication immediately after their return to the Czech Republic. This obligation does not apply to persons who were granted an exception pursuant to the resolution of the Government No. 198 of March 12, 2020 and No. 203 of March 13, 2020;
- 2. All healthcare services providers for general medicine or pediatric medicine to decide on imposing of 14-day quarantine, pursuant to Section 2(7)(a) of the act No. 258/2000 Coll., of all persons with temporary or permanent residence in the Czech Republic, residing in the territory of the Czech Republic for more than 90 days or if they are employed in the territory of the Czech Republic, who return, after the moment of effect of this resolution, from risk areas, as specified by the minister of healthcare pursuant to the resolution of the Government of March 12, 2020 No. 198, to the Czech Republic;
- 3. All persons with any symptoms of the influenza disease, to whom the obligation as per point 1 does not apply, to immediately inform of this their registered healthcare services provider for general medicine or pediatric medicine or, if they do not have any, any healthcare services provider for general medicine or pediatric medicine by phone or other means of remote communication;

4. It is recommended to all truck and bus drivers, passenger aircraft crews, train drivers, train crews and train masters, boat captains and boat crew members, crews of vehicles of road administrators, who pursue transit or transportation across the territory of the risk areas, as specified by the minister of healthcare pursuant to the resolution of the Government of March 12, 2020 No. 198, to limit their direct contact with local staff in the territory of these risk areas as much as possible.
