

# RESOLUTION OF THE GOVERNMENT OF THE CZECH REPUBLIC

dated March 16, 2020, No. 239

### on the adoption of an emergency measure

Following the resolution of the Government No. 194 dated March 12, 2020, according to which the Government declared, pursuant to Articles 5 and 6 of the constitutional act No. 110/1998 Coll., on security of the Czech Republic, the state of emergency for the territory of the Czech Republic due to the risks for public health in connection with the evidenced occurrence of the coronavirus /referred to as SARS CoV-2/ in the territory of the Czech Republic, and ruled to adopt emergency measures pursuant to Section 5(a-e) and Section 6 of the act No. 240/2000 Coll., on emergency management and amending of several acts (the emergency act), as amended, to solve the emergency situation, hereby, pursuant to Section 5(c, e) of the emergency act.

#### The Government

#### I. Orders

- Persons who are recipients of a social service by social services providers, who were granted registration to the provision of social services pursuant to Sections 48, 49 or 50 of the act No. 108/2006 Coll., on social services, as amended (homes for incapacitated persons, retirement homes, homes with a special regime), not to leave the premises or area of the facility, in which the aforesaid social service is provided, for the duration of the state of emergency;
- 2. The social services providers who provide social services specified in the point I/1 hereof to inform all persons, on whom the ban as per point I/1 was imposed to, or their guardians of the measure specified in point I.1 hereof;
- 3. The social services providers, who were granted registration to the provision of social services pursuant to Sections 45, 47, 62, 65, 66 and 67 of the act No. 108/2006 Coll., on social services (centers of daily services, weekly social welfare institutions, low-threshold facilities for children and youth, services of social activization for families with children, services of social activization for seniors and incapacitated persons, socially therapeutic workshops), to suspend provision of such services as of March 18, 2020 for the duration of the state of emergency;
- 4. The social services providers to suspend provision of social services on the basis of a contract concluded with a user pursuant to Section 91 of the act No. 108/2006 Coll., on social services and, at the same time, suspend provision of the service in the individual planning regime for the duration of the state of emergency. The provider shall inform the users demonstrably of this change;
- 5. The social services providers to provide services to the necessary extent to protect life and health of people. Services may be provided with the engagement of social services providers whose operation was suspended hereby or use students in accordance with the resolution of the Government of the Czech Republic of March 13, 2020 No. 207,

- 6. The heads of regional administration and mayor of the capital city of Prague
- a) ensure provision of another appropriate social service or provision of a different type of care to the necessary extent and only in cases of immediate threat to life and health of the social service users as per point I/3 hereof, in collaboration with municipalities, in which these users have their actual place of residence;
- b) inform the Ministry of Work and Social Affairs of the implementation of the measure as per point I/6 hereof;
- **II. Instructs** the minister of work and social affairs to inform the social services providers of measures provided in points I/1, I/3, I/4, I/5 and I/ 6 hereof, provide methodical guidance in their implementation and manage provision of the social services for the duration of the state of emergency.
