

## RESOLUTION OF THE GOVERNMENT OF THE CZECH REPUBLIC

dated March 23, 2020, No. 280

## on adopting an emergency measure

Following the Governmental Resolution No. 194 dated March 12, 2020, by which the Government, in line with Art. 5 and 6 of the Constitutional Act No. 110/1998 Coll., on Security of the Czech Republic, declared a state of emergency for the territory of the Czech Republic due to threat of health in connection to proven outbreak of coronavirus /designated SARS CoV-2/ in the territory of the Czech Republic and in line with Section 5 letter a) to e) and Section 6 of the Act No. 240/2000 Coll., on Emergency Operation and on change of other Acts ("Emergency Act"), as amended, for the purpose of resolving the emergency situation, the Government hereby decided on adoption of emergency measures, under Section 5 letter e) and Section 6 (1) letter b) of the Emergency Act, as follows:

## The Government

- **I. acknowledges** the Extraordinary Measure of the Ministry of Health dated March 23, 2020, file No. MZDR 12746/2020-1, by which the prohibition of retail sale and sales of services and other activities with exceptions was prolonged, for the period up to April 1, 2020 until 6:00.;
- **II. obliges** that for the period of the state of emergency issued by the Governmental Resolution No. 194 dated March 12, 2020
- 1. with the employees, whose employment relationship is commenced from the day of issuance of this measure, the following can be replaced by an affidavit, template of which forms Annex No. 1 to this measure:
  - a) health card under Section 19 (2) of the Act No. 258/2000 Coll., on Protection of Public Health and on change of certain other related Acts, as amended, and
  - b) assessment of health capacity of person applying for employment under the Act No. 373/2011 Coll., on Specific Medical Services, as amended,
- is not necessary to perform periodical medical exams within the sense of Section 11 of the Decree No. 79/2013, on Implementation of Certain Provisions of the Act No. 373/2011, on Specific Medical Services, as amended (Decree on Employment Medical Services and Other Types of Assessment Services), as amended,
- 3. validity of work permits and permissions and visas for stay issued until the day of issuance of this measure to persons in employment relationship with employers, who provide services based on the agreement under the Section 308 of the Act No. 262/2006 Coll., the Labour Code, as amended, or based on other contract, is prolonged for the period of 60 days after termination of the state of emergency, provided that they are valid as of the day of issuance of this measure,
- 4. other conditions stipulated in the implementing regulation related to introduction of packed goods to the market need not to be adhered to.
- **III. prohibits** with the effect as of March 24, 2020 from 6:00 until April 1, 2020 the validity of the Directive by which a municipality determines areas of the municipality, in which the

local communications or their specified parts can be used for a price agreed under price regulation;
