

# RESOLUTION

# OF THE GOVERNMENT OF THE CZECH REPUBLIC

#### dated March 23, 2020, No. 293

## on amendment of the Resolution No. dated March 19, 2020, No. 257 on Target program to support employment

## The Government

**amends** the Government Resolution dated March 19, 2020, No. 257, on Target Program to support employment as follows:

- 1. point I. now reads "approves",
- inserts new point I/1 with wording: "Target program to support employment (hereinafter referred to as "Target program"), the estimated costs of its implementation and its execution schedule", as amended by proposed amendment of the submitter on March 23, 2020,
- 3. inserts new point I/2 with wording: "Target Program to support employment part II., estimate of monthly costs on its implementation and its execution schedule", contained in the document file No. 254/20.
- 4. point II/2 newly reads: "Minister of Labor and Social Affairs to ensure the implementation of regime B (payment of contribution for the wages or salary compensation pursuant to Section 208 LC due to the impossibility of allocating work in connection with the issuance of emergency resolutions by the Government of CR and extraordinary measures of the Ministry of Health for protection of public health in connection with the spread of the COVID-19 disease, especially the extraordinary measure issued by the Ministry of Health dated March 10, 2020, file No. MZDR 10666/2020-1/MIN/KAN, Government Resolution dated March 12, 2020 No. 199, Government Resolution dated March 12, 2020 No. 201, Government Resolution dated March 13, 2020 No. 208, Government Resolution dated March 14, 2020 No. 211, Government Resolution dated March 15, 2020 No. 215, and those directly following) specified in part II.6.2 of Target program, through the Labor Office of the Czech Republic,
- 5. point II/3 newly reads: "Minister of Labor and Social Affairs to ensure the implementation of regime C (payment of contribution of the wages or salary compensation due to impossibility of allocating work due to imposed quarantine or on connection with occurrence of significant obstacle on the side of the employee under Section 191 of the Act No. 262/2006 Coll., the Labor Code, as amended (hereinafter referred to as "LC") caused by the care for a child younger than 10 years in connection with issuance of the Government Regulation dated March 13, 2020 No. 201 and following within 30% of employers employees) specified in part II.6.1 of the Target program to support employment part II. through the Labor Office of the Czech Republic,
- 6. inserts new point II/4 with wording: "Minister of Labor and Social Affairs to ensure the implementation of regime D (payment of the contribution for the wages or salary compensation due to occurrence of obstacle on the side of employer pursuant to Section 207 letter a) LC due to restriction of availability of inputs necessary for activities of the employer due to quarantine measures (or generally outage of production in causal nexus with COVID-19 infection) of their supplier, including abroad), specified in part II.6.2 of the

Target program to support employment - part II. through the Labor Office of the Czech Republic,

- 7. inserts new point II/5 in the wording: "Minister of Labor and Social Affairs to ensure the implementation of regime E (payment of the contribution for wages or salary compensation due to occurrence of obstacle to work on side of the employer pursuant to Section 209 LC due to restriction of demand for services, goods and other products of employer as a result of quarantine measures in place of the market or in other ways in causal nexus with COVID-19 infection) specified in part II.6.3 of the Target program to support employment part II. through the Labor Office of the Czech Republic,
- inserts new point II/6 in the wording: "Minister of Labor and Social Affairs to submit to the Government of CR for approval a request for excluding means for first allocation of both parts of the Target program to support employment specified in points I.1 and I.2 for March 2020.",
- 9. inserts new point II/7 in the wording: "Minister of Labor and Social Affairs to execute mutual methodic of both parts of the Target program to support employment specified in points I.1 and I.2 and submit it to the approval of the Government of CR",
- 10. in part To be implemented by: the words "Deputy Prime Minister and Minister of Finance" are removed.
